#### FRESNO PLANS FOR VIRTUAL BOARD ELECTION by Dick Estel Fresno County CRCEA Alternate Delegate

Recently I read an article that posited that the real divide in our country is between political junkies and everyone else – about a 20/80 split. This resonated with me because the board of the Retired Employees of Fresno County (REFCO) have been struggling with how to hold an election for board officers without having an annual meeting/lunch.

Our bylaws call for the election to be held at the Annual Meeting, which is our February lunch. We talked about mail-in ballots, voting via email and on the web site. Then I started thinking about past elections.

At the meeting the chair of the Nominating Committee announces the names (which have previously been reported in our newsletter), and calls for nominations from the floor. There are never any such nominations. Then by pre-arrangement a member moves to elect the slate of officers by acclimation. motion passes unanimously. The electorate at these lunches is less than 200 people, while our total membership is close to 3,000.

My analysis: As long as the checks arrive on time, a newsletter comes out, and those who choose to can get together for lunch six times a year, 99% of our membership does not care who the president or board members are.

With this in mind, we decided not to spend \$1,500 to mail paper ballots, but instead to conduct the election via our website. In our newsletter article naming the candidates, we invited members to nominate via email or phone (in lieu of "from the floor"). Two months later we have matched the usual number of such nominations – zero.

Our next newsletter will explain the on-line voting process, which will start about mid-January. Although this does not match up with requirements in the bylaws, we have decided that the unforeseen, and hopefully once a century, conditions we are dealing with call for extraordinary flexibility.

At some point we want to amend the bylaws to allow for unusual events. But, to do so, we have to have a vote of the membership at a regular meeting (one of the six lunches). It's a regular Catch 22 – can't meet and can't amend without a meeting. Stay tuned for the next chapter of "COVID-19 vs the World."
